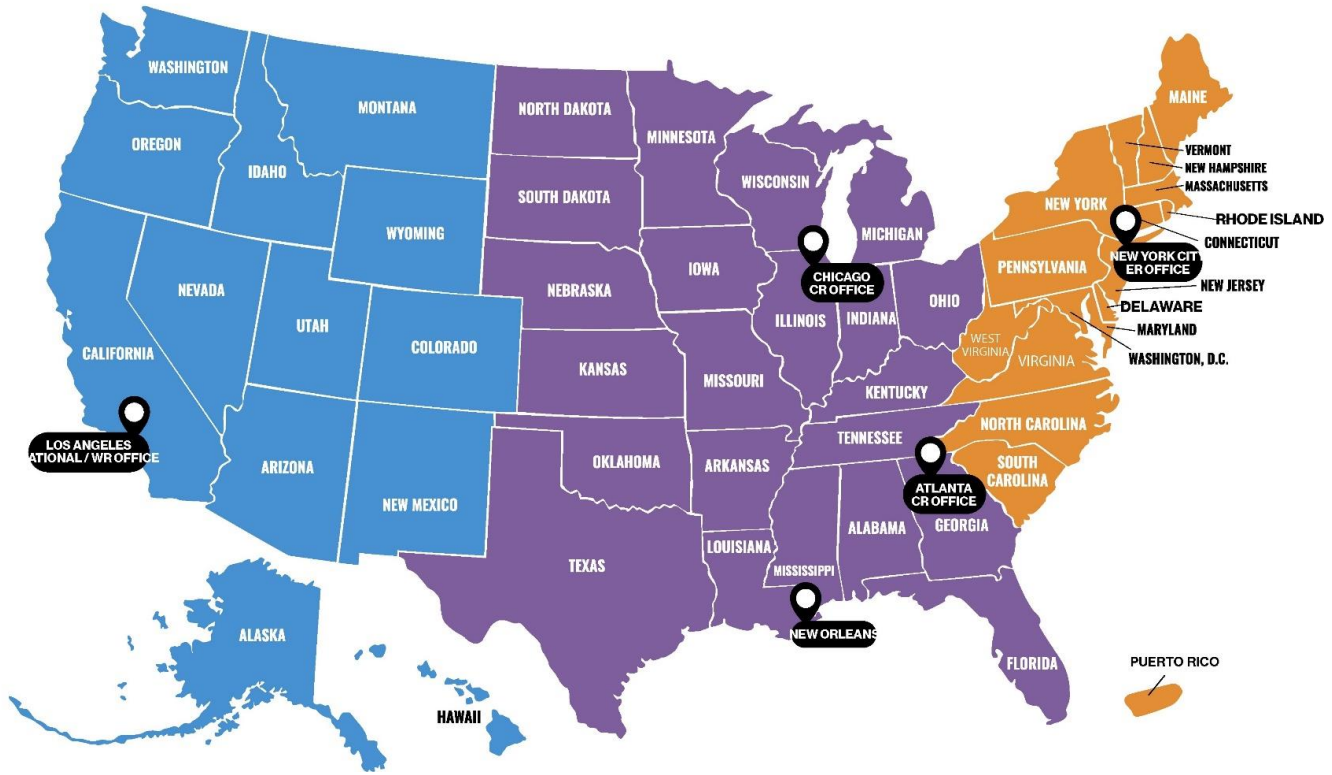


Local 600 Regional Map
